Cllr Proctor would normally chair the Planning Cttee but will not chair this item as there has been so much local interest and he will in fact be speaking against the item because only three months ago there was a different application for 12 houses on the same site. Local residents and the Parish Council believe that it is an inappropriate development and also unnecessary. The Planning Committee will decide whether to permit or to refuse. Only material planning reasons can be used to object to this application.

Draft Budget 18/19 - to consider priorities - see attached Appendix A A decision has been taken to support the economy of Audley village by adopting and maintaining the two main car parks, currently the responsibility of NBC. Some remedial work has already been done, but it is likely that the Methodist Church car park will have to be closed for one day for further work. Both the Co-op and Tesco have submitted applications to their Head Offices to support the work. It was agreed to discuss the further at the next Next meeting, and to consider resolving to close car park for one to two days. agenda Proposed and seconded to set aside £3,500 for car parks within the budget for 18/19.
